MINUTES OF MEETING

May 29, 2023 - 6:00 PM

Call meeting to order/adoption of agenda:-

A regular meeting of the Bonavista Town Council was held on Monday, May 29, 2023, at 6:10 p.m. in the Council Chambers. There were five members present; Councillors David Hiscock, Barry Randell, and Colleen Tinkham were present in the Chambers. Mayor John Norman and Councillor Nicole Abbott joined the meeting via videoconference. CAO/Clerk Stephanie Lodge, ECHO Crystal Fudge and Youth Representative Noah Butt were also present.

The meeting was presided over by the Mayor.

It was moved by Councillor Randell and seconded by Councillor Hiscock that the agenda of the meeting held on May 29, 2023, be adopted as read with an amendment to include 51 Canon Bayley Road under the permits section. Motion carried unanimously.

Adoption of minutes:-

It was moved by Councillor Hiscock and seconded by Councillor Tinkham that the minutes of the meeting held on May 8, 2023, be adopted as read. Motion carried unanimously.

Committee Reports:-

<u>Recreation Committee Meeting – Presented by Councillor Abbott (see attached minutes)</u>
All recommendations presented in the report were agreed upon by Council.

Administrative Notes:-

- Tax write-off: It was moved by Councillor Hiscock and seconded by Councillor Randell to write off the account of the late Una Noble-Phillips in the amount of \$1,700. Motion carried unanimously.
- Paving estimates: An estimate was received to pave a section of Wells' Road and Bake Pot Pond Road for \$18,000 and \$17,000 respectively. As this was not budgeted for, and there is already a cost overrun for the current capital works paving project, it was decided not to move forward with this work. Significant repairs will be made to the section of Bake Pot Pond Road this year by the Town Crew and the section of Wells' Road will be included in this year's capital works application.

Finances:-

1. A list of bills for approval to pay was presented. A copy of this list of bills is attached. It was moved by Councillor Tinkham and seconded by Councillor Hiscock that these bills in the amount of \$66,156.74 be paid. Motion carried unanimously.

Also present at the meeting was Stephanie Lodge, CAO, and Lloyd Stagg, Director of Recreation and Community Services.

Councillor Abbott called the meeting to order at 3:45 p.m.

Chalet at Cape Bonavista – Work will begin soon on repairs from lightening storm damages. It was noted there are additional repairs to the chalet that need to be addressed.

Soccer Field/ Softball Field Update – Work is continuing on the soccer field. The softball field needs to be salted/sanded. This will require additional salt as there is not enough on hand, and the purchase of silica sand for infield for approximately \$1,850.00.

Church Street Festival – A discussion arose regarding possible events to hold during Church Street Festival (Bouncy castle, disc golf, BBQ, ball hockey, pickleball, etc.).
