# Councillors' Concerns: -

Mayor Norman's concerns: -

- 1. Cruise Ships The Harbour Authority met with MHA Craig Pardy and have agreed to proceed. ECHO will set up a meeting with the Authority to discuss next steps.
- 2. Ambulance Services Mayor Norman has been receiving complaints regarding ambulance service since operations are now with NL Health Services. This topic will be added to the agenda for the meeting with the Premier/Minister next week.
- 3. Physician update Mayor Norman stated that patients continue to attack local physicians on social media which is having an extremely negative effect on physician recruitment and retention at the Bonavista Hospital. It was agreed to purchase an appreciation gift for physicians.
- 4. Train on Station Road Mayor Norman stressed the dangers associated with leaving the train in its current condition. ECHO will reach to MANL to see if there is an expert to come and examine its condition and likelihood/cost of restoration.

# Councillor Hiscock's concerns: -

1. Town Plan – There will be a meeting with Council and a public meeting before the plan is approved.

#### Councillor Abbotts' concerns: -

- 1. Snowclearing the track DEO stated while this is not a high priority, the track is cleared when time permits.
- 2. Pickleball and Badminton A group of residents are organizing a pickleball and badminton group and will be renting the school to play in.
- 3. Winter wellness social media contest Consists of winter activities and will be a great way to get residents active and engaged.

# Deputy Mayor Butler's concerns: -

- 1. Dungeon Road (Pinnacle) The road has started to wear away. MHA Craig Pardy is looking into this.
- 2. Seawall (Red Point) There is a hole in the gravel where the seawall ends. This is also occurring near the seawall in Rolling Cove and is dangerous for traffic and pedestrians. DEO to address the issue and cover with topsoil in the spring as a more permanent fix.

- 1. Tourism levy There has been no correspondence from the Government regarding a by-law. Management will hopefully start working on the levy this year, with a goal of 2026 implementation.
- 2. Public building Major renovations are required. This will be discussed at the upcoming meeting with the Townscape Foundation.

#### Councillor Phillips' Concerns:-

- 1. Seawall along Long Beach and Swyers' Beach possible funding options were discussed. This will be addressed with Craig Pardy.
- 2. Cold patch needed on Provincial Roads DEO will contact the Department of TI.
